The Managers have announced the issuance of an aggregate of 11,584,960 new Stapled Securities in FHT on 13 May 2020 for the payment of the REIT Manager's, Trustee-Manager's and MIT Manager's management (base) fee, and the serviced residence management fees by way of issue of new Stapled Securities. The total number of issued Stapled Securities increased from 1,909,658,067 to 1,921,243,027. The issuance of the new Stapled Securities resulted in a change in the percentage level of the direct interest in FHT held by FPHTH.



(b) FHTM nominated FPHTH to receive 37,063 Stapled Securities issued as payment of the base fee component of the trustee-manager management fee in respect of FH-BT;  
(c) FHT Australia Management Pty Ltd nominated FPHTH to receive 2,214,465 Stapled Securities issued as payment of the base fee component of the MIT management fee in respect of FHT Australia Trust;  
(d) Frasers Hospitality Pte. Ltd. nominated FPHTH to receive 2,625,000 Stapled Securities issued as payment of serviced residence management fees in respect of the non-UK properties of FH-REIT; and  
(e) Frasers Hospitality UK Ltd. nominated FPHTH to receive 1,703,651 Stapled Securities issued as payment of serviced residence management fees in respect of the UK properties of FH-REIT.

The percentage of stapled securityholdings "immediately after the transaction" is computed based on 1,921,243,027 Stapled Securities in issue as at 13 May 2020.
