The Managers have announced the issuance of an aggregate of 11,584,960 new Stapled Securities in FHT on 13 May 2020 for the payment of the REIT Manager, Trustee-Manager and MIT Manager's management (base) fee, and for the payment of serviced residence management fees by way of issue of new Stapled Securities. The total number of issued Stapled Securities increased from 1,909,658,067 to 1,921,243,027. This resulted in a change in the percentage level of the deemed interest in FHT held by Thapanee Techajareonvikul.
