DISCLOSURE PURSUANT TO RULE 704(31) OF THE SGX-ST LISTING MANUAL

Pursuant to Rule 704(31) of the Listing Manual of the Singapore Exchange Securities Trading Limited ("SGX-ST"), Frasers Hospitality Asset Management Pte. Ltd., as manager of Frasers Hospitality Real Estate Investment Trust ("FH-REIT", and in such capacity, the "Manager"), wishes to announce that Perpetual (Asia) Limited, as trustee of FH-REIT, has entered into the following loan facility agreement with the conditions (the "Relevant Conditions") as set out below which make reference to a change in the manager of FH-REIT, and places restrictions on a change of control of the Manager.

Relevant Conditions

Facility agreement dated 12 April 2023 It is a mandatory prepayment event if, without the prior in relation to the S\$120 million revolving written consent of the Lender (i) the Manager resigns credit facility entered into between or is removed as manager of FH-REIT and is not Perpetual (Asia) Limited (in its capacity replaced by a substitute approved by the Monetary as trustee of FH-REIT), as borrower Authority of Singapore; or (ii) Frasers Property Limited "Borrower"), and Overseaceases to hold, whether directly or indirectly, at least 51 per cent. of the issued share capital of the Manager Chinese Banking Corporation Limited, as lender (the "Lender", and the facility (a "Change of Manager"). agreement, the "Facility Agreement") If a Change of Manager occurs and upon the demand of the Lender: (i) the Commitment (as defined in the Facility Agreement) shall be immediately be cancelled; and (ii) the Borrower shall immediately prepay all outstanding loans under the Facility Agreement together with accrued interest and all other amounts owing under the documents designated as "Finance Documents" in the Facility Agreement.

None of the events described under the Relevant Conditions have occurred and none of the conditions described under the Relevant Conditions have been breached. Assuming an event under the Relevant Conditions occurs, and a failure to prepay causes a cross default under other

borrowings of FH-REIT, the aggregate level of facilities that may be affected is approximately S\$658.7 million (excluding interest and exclusive of the facility which is the subject of this announcement) as at the date of this announcement. This does not take into account (i) the amount of the loan facilities which have not been, and remain available for, drawdown and (ii) future notes issuances under the S\$1,000,000,000 multicurrency debt issuance programme of FH-REIT Treasury Pte. Ltd. (a wholly-owned subsidiary of FH-REIT) and guaranteed by Perpetual (Asia) Limited (in its capacity as trustee of FH-REIT).
