# CHANGES IN THE COMPOSITION OF THE BOARD OF DIRECTORS AND THE AUDIT, RISK AND COMPLIANCE COMMITTEE

- 1. Frasers Hospitality Asset Management Pte. There is no change to the existing composition of the NRC of each of the Managers.
